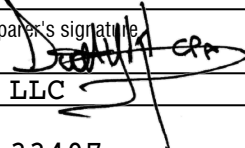

The process of application, review, approval, maintenance, and renewal process are the same for all programs. The application process is administered by a volunteer scholarship committee, which receives, processes, and maintains all applications and related documents.

All decisions including approval of all scholarships and grant award amounts are the sole discretion of The Palm Beach Police & Fire Foundation Scholarship Committee except for Indirect Scholarships.

> The Foundation will offer two (2) annual scholarships to Cardinal Newman High School. One (1) for a child of a Police Officer and one (1) for a child of a Firefighter. Cardinal Newman High School will fund up to \$10,000.00 and the Foundation will fund the balance. The student must apply directly to Cardinal Newman High School and pass the admission exam. (For the Police Department Step Up Law Enforcement eligibility available)

The Palm Beach Police & Fire Foundation Scholarship program is available to all students meeting the minimum qualifications listed and who are enrolled in a two (2) or four (4) year program. Students initially selecting a two-year program of sixty (60) credits may transfer to a university and continue their education for two (2) additional years.

> \$7,000 per year for Florida State Colleges and Universities, Out of State Colleges and Universities, and Community Colleges.

Trade Schools and Vocational-Technical Schools will be covered at exact cost. Students are required to submit a copy of program costs and expenses to receive funds. Program cost (maximum of \$10,000.00 per year) for Trade Schools and Vocational-Technical Schools.

The Brian P. Burns Educational Scholarship is for those undergraduate and graduate students who achieve a GPA of 3.0 or GPA of 3.2 or higher. In addition to the basic qualifications, these students must have a final GPA at the end of each school year of 3.0 (Undergraduate), GPA of 3.2 (Graduate) or higher to qualify. Students may earn this additional scholarship award on an annual basis. The Award is \$3,000 per year for both undergraduate and graduate education for Florida or Out of State Colleges and University programs. Students graduating in 2026 or later are required to participate in and complete the College Admissions Group Counseling course in order to be eligible for the Brian P. Burns Educational Scholarship.

The graduate studies scholarship is for advanced degree programs only, and is intended to follow successful completion of a undergraduate program.

Advanced programs include masters, doctorate degrees, and other post-graduation specialty programs. Students must have a 3.2 GPA and successful completion of required post-graduate entrance examinations. The applicant must have been accepted to a master's, doctoral, or specialty degree program. Students may apply after graduation and before the age of 26 if all other qualifications are met. The annual award amount is \$6,000.

Graduate students with a GPA of 3.2 or higher are also eligible for the Brian P. Burns Educational Scholarship

iii.) a retired employee of the Town of Palm Beach Police & Fire Department with at least 20 years of service and retired by town rules following regular retirement and separation of employment within the past 5 years.

4. Student must have graduated from high school, or expect to graduate from high school, or possess a G.E.D by the initial application due date and have an initial unweighted Grade Point Average of 2.0. Trade school and Vocational school full time students per program coursework.
